1. Roll Call

In absence of the chair Deputy Mayor Robin Gibson chaired the meeting and called the meeting to order.

2. Minutes - April 6, 2021 Meetings

The minutes of the second meeting on April 6, 2021 were reviewed. Deputy Mayor Robin Gibson confirmed that they are accurate and made a motion to approve the minutes. The motion was seconded.

3. Review Of Provisional Ballots

Jennifer Nanek, City Clerk, said that there are two provisional ballots to review.

Deputy Mayor Robin Gibson asked if provisional ballots are ballots submitted because the first one isn't valid. Ms. Nanek said in these two cases the voters voted by mail but claimed not to have done so. They voted provisionally at their precinct.

The first was submitted by L Eunice Mehle, voter ID# 113830962, who voted by mail. The Vote-By-Mail ballot was counted Tuesday night. The canvassing board reviewed the copy of the Vote-by-Mail certificate and the provisional ballot. Jim Reddick asked if the Vote-By Mail ballot was received well ahead of Election Day. Ms. Nanek said it was.

Deputy Mayor Robin Gibson made a motion to reject this ballot. Commissioner Howell seconded the motion.

Motion passed 3-0.

The second provisional ballot was submitted by Diana Cottone. Ms. Cottone's Vote-By Mail ballot was signed by Vincent Cottone and was rejected by the canvassing board on Tuesday night. The question is whether or not to accept Ms. Cottone's provisional ballot. The copy of the Vote-by-Mail certificate and provisional ballot were reviewed by the board. Jim Reddick said the voter did not use her vote by mail ballot. Her provisional ballot should be acceptable. Deputy Mayor Robin Gibson said he wanted to be sure her vote got counted. Commissioner Howell said she didn't get to vote twice.

Jim Reddick made a motion to accept Diana Cottone's provisional ballot. Commissioner Howell seconded the motion.

Ms. Nanek opened the ballot and added the votes to the tally of results.
