We understand and agree that if we do not comply with the rules of the parade, and the instructions given to us by parade marshals, City of Lake Wales Police Department, our participation in the parade will be terminated and we are not permitted to continue in the parade.

The Dr Martin Luther King, Jr. Committee reserves the right to deny any application.

Once the application has been approved the undersigned agrees there will be no refund of parade fees for any reasons.
